The Brutal Facts

 For many in the professional safety community, pipeline construction safety is perceived as 10-15 yrs behind leading edge industrial

construction safety cultures, systems and behaviors.

- Why? Perhaps...
 - Boom and Bust cycles
 - Bumpy transition from a family environment to disciplined pipeline construction workforce performance management approaches
 - Associations, regulators, and owners too quiet on safety; especially when compared to facilities applications (i.e. "inside the fence" vs. "outside the fence")
 - A business environment that says you can't be bad at safety but why be great?
 - A culture where productivity trumps occupational safety
 - Barriers between parties (open/closed shop, owner/contractor, associations, regulators)



The Path Forward

- Until we start to identify and action a coordinated agenda across all parties, high performance safety will be difficult to achieve. Where it does happen, it will likely only occur in pockets.
- I think the INGAA Foundation is uniquely positioned to leverage a community effort; a coordinated agenda that can help us "catch up" on safety in a way that's nearly impossible if we're acting individually.
- One of the greatest safety thought leaders of our generation (Dr. Dan Peterson) taught us that if you really want to make a change on safety, pick out a sacred cow and KILL THAT COW.




What is possible? (a.k.a. What "cows" have others killed?)
