Our pipelines have been designed and constructed with the utmost concern for providing a safe and quality product. We assess construction and operating risks, and develop and implement plans to eliminate or minimize risks and threats to safe operation while maintaining a high quality standard throughout the life cycle of the assets. We pursue continuous improvement on safety and quality. We hire, maintain and train a workforce that has the experience, skills and resources to design, construct, operate and maintain a safe and high quality pipeline system.
